HOME HEALTH ELIGIBILITY REQUIREMENTS

Our staff will work with your physician to assist you in determining your homebound status. If you are receiving Medicare benefits, you can use your home health benefits if you meet all of these conditions:

- 1) You must be under the care of a doctor, and be receiving services under a plan of care established and reviewed regularly by a doctor
- 2) You must need, and a doctor must certify, that you require one or more of the following intermittent services:
 - Skilled nursing care
 - Physical therapy
 - Speech therapy
 - Occupational therapy
- 3) The home health agency caring for you must be approved by Medicare (Medicare-certified)
- 4) You must meet Medicare homebound criteria, and a physician must certify this need. To be homebound means:
 - Leaving your home isn't recommended because of your condition
 - Your condition keeps you from leaving home without assistance (you require a wheelchair or walker, special transportation, or assistance from another person)
 - Leaving home takes a considerable and taxing effort

A person may be able to leave home for medical treatment or short, infrequent absences for non-medical reasons, such as attending religious services.
